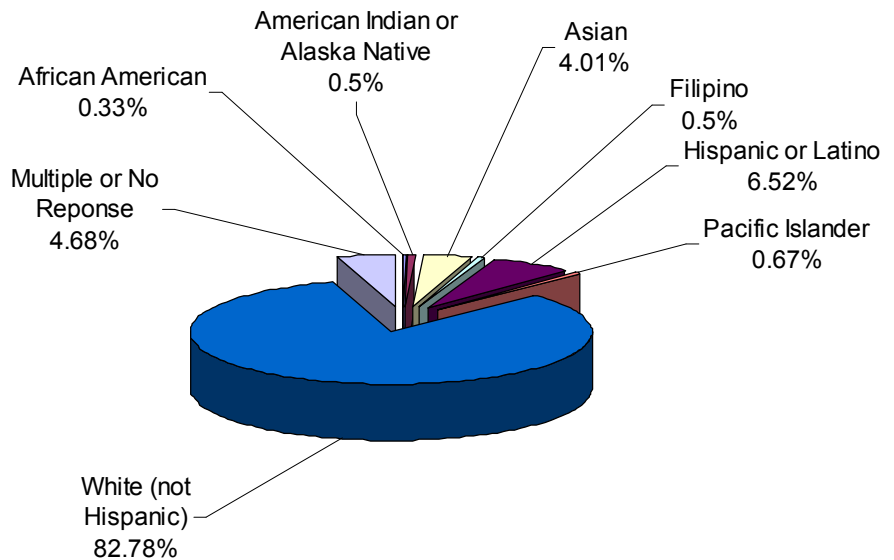

## School Facilities
