SUPERINTENDENT'S REPORT

- Superintendent Penny Weaver gave a brief overview of process and plans put into motion on December 1st and 2nd when damaging high winds were experienced in the area. She reminded the Board that on October 5th the entire district staff participated in emergency preparedness training where similar scenarios were described and actions discussed. SVHS was closed on December 1st due to the safety issue of flying roof debris. The situation helped identify areas for improvement and further discussion. In all, the situation was handled very well and all staff is to be commended for their decisions and dedication to safety for all students.
- Thanks to the hard work of the Director of Curriculum and Instruction Kathy Dunton and the Director of Technology Carl Guerin, the first round of benchmark assessments is nearly complete. The district will be able to analyze students' progress.
- In January the 2012-13 budget development will begin. Chief Business Official Vickie Clark and Superintendent Weaver will meet with each site administrator to assess enrollment projections which drive many decisions.

STUDENT ADVISORY MEMBER'S REPORT

Student Advisory Member Alex Kalinowski said the blood drive scheduled for Friday, December 2nd was cancelled due to power outages but will be rescheduled after finals. The sports rally was held last Friday and gifts were turned in for the Adopt-A-Family. The play The Curious Savage was performed even with the power outage. The holiday assembly for the performing arts will be held this Friday and then students will be getting ready for finals.

Board Member Sue Roth said she had no information to pass on from the SCCSBA. CSBA decided to talk about what Board members learned and participated in during the Annual Education Conference in San Diego on December 1 through 3, 2011.

SVEA REPORT

SVEA President Mike Hanson said the play The Curious Savage was performed the first night even with the power outage. SVEA members feel they are well informed about the district's financial situation. SVEA was actively involved in the education parcel tax work groups with several teachers attending the meetings. Mr. Hanson said communication is good and SVEA feels they have an active part.

Weaver

1. **Review a Draft Resolution Proposing an Education Parcel Tax Measure Establishing Specifications of the Election Order**

Superintendent Penny Weaver gave a quick overview of the chronology of events including the two work group meetings on November 29th and December 5th where representatives from SVEA, administration, Board members, seniors, community members, city officials, classified employees and parents collaborated on the education parcel tax resolution language. Ms. Weaver extended her thanks to all members who gave of their time to work on the resolution. She requested Board members to proceed with their discussions and then give direction to staff. Board members' discussion included the positive atmosphere of the work groups to develop resolution language that was precise yet flexible to accommodate changes from the state.

Allen Reames, Derek Timm and Randy Johnson addressed the Board regarding this agenda item.

Board discussion continued regarding the amount, duration and election date of a parcel tax and if another poll of the community was necessary. Various ways of obtaining information regarding the willingness of the community to support a parcel tax was discussed with the decision made to contract with a polling company. Board members expressed their desire to have input into the polling questions with Board President Larry Beaman and Board Member Michael Shulman volunteering to participate. Board President Beaman gave direction to Superintendent Weaver to contract a polling firm for as much as \$10,000 to conduct a survey.

2. **Select Two Members to Participate in the Scotts Valley High School WASC Focus Groups**

Superintendent Weaver briefly explained the process and the importance of WASC (Western Association of Schools and Colleges). Scotts Valley High School Principal Valerie Bariteau and Scotts Valley High School Teacher Naomi Lyle provided information about the five focus groups and which groups would benefit most from the participation of Board members. Board Members Michael Shulman and Art Bubb will participate on the focus groups, with Sue Roth as the alternate. Ms. Bariteau explained there would be approximately five meetings beginning this spring and would be held Wednesday afternoons from 1:30-3:00pm.
