NOTICE IS HEREBY GIVEN that the Board of Education of the Scotts Valley Unified School District will hold a public hearing on May 8, 2012, at 6:00 P.M. or as soon thereafter as the matter may be heard, to consider adoption of a resolution entitled "RESOLUTION OF THE BOARD OF TRUSTEES OF THE SCOTTS VALLEY UNIFIED SCHOOL DISTRICT ADOPTING RESPONSES TO PUBLIC COMMENTS RECEIVED, APPROVING SCHOOL FEE JUSTIFICATION STUDIES, ADOPTING LEVEL 1 RESIDENTIAL SCHOOL FEES AND LEVEL 1 COMMERCIAL/INDUSTRIAL DEVELOPMENT FEES IN COMPLIANCE WITH EDUCATION CODE 17620 and GOVERNMENT CODE SECTION 65995 AND MAKING RELATED FINDINGS AND DETERMINATIONS" which would, if approved, adopt the Residential Development School Fee Justification Study and the Commercial/Industrial Development School Fee Justification Study, dated April 26, 2012 and authorize the levy of Level 1 (\$3.20 per square foot) residential school fees and Level 1 (\$0.51 per square foot) commercial/industrial school fees. The School Fee Justification Studies justifying these fees have been prepared and will be available for public review at the District Administration Office on and after April 27, 2012, located at 4444 Scotts Valley Drive, Suite 5B, Scotts Valley, California. The hearing will be held at the Scotts Valley City Council Chambers, One Civic Center Drive, Scotts Valley, California.
